Mr. Foley This is from the Ohio Revised Codes: All roads that, absent annexation, would have been considered and maintained as TOWNSHIP'S roads shall count as TOWNSHIP'S roads for road tax purposes and gas tax distribution due to the TOWNSHIP'S obligation to maintain those roadways; further, TOWNSHIP and CITY specifically agree that this provision is both authorized and necessary under Ohio Revised Code Section 701.07.

I feel it is very important, now that we have the residential development within the C.E.D.A Territory such as the Ryan Homes behind Walmart, the annexation at Burnett and Leffel. I think it is very important that if we receive the road mileage, we receive the tax money that goes with it. If I have your blessing, I will send a letter to the City and the County Commission, voicing our concerns.






