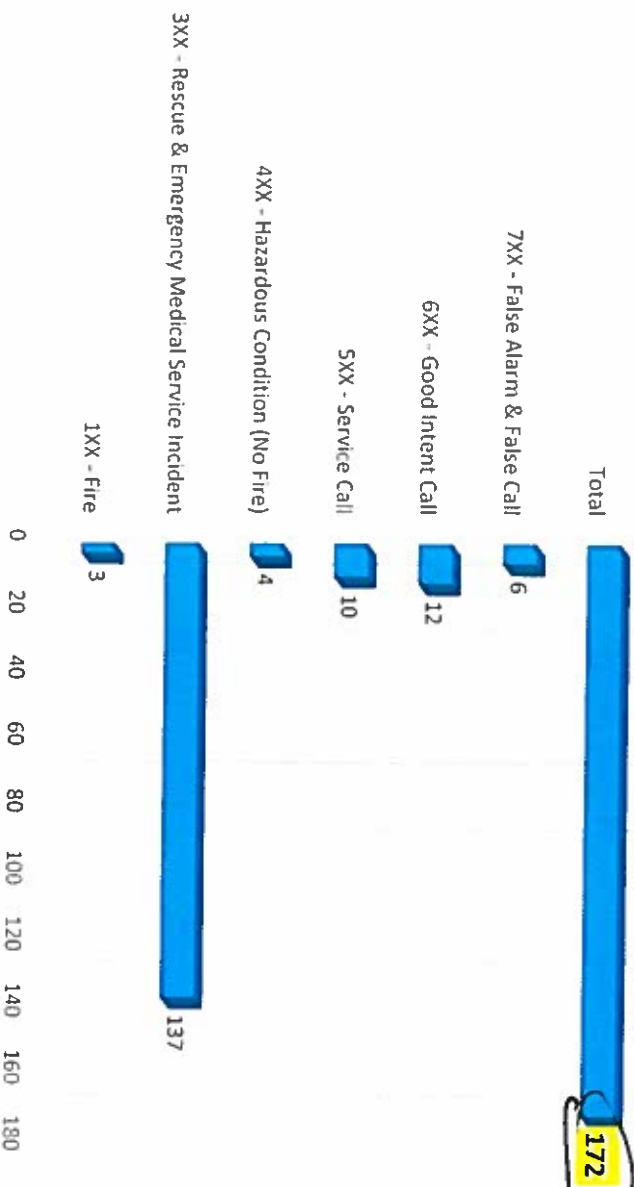

# January Fire Department Call Volume



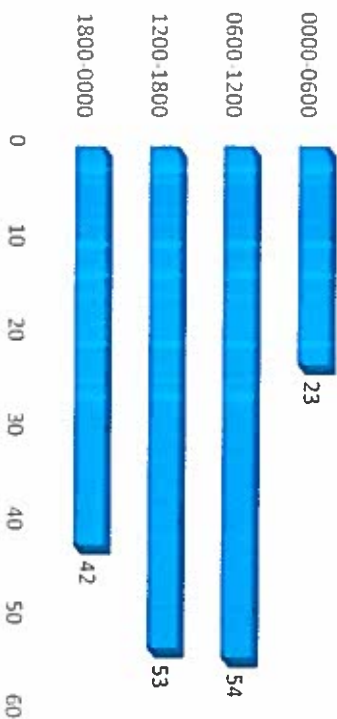
## Call Volume By Type Of Call



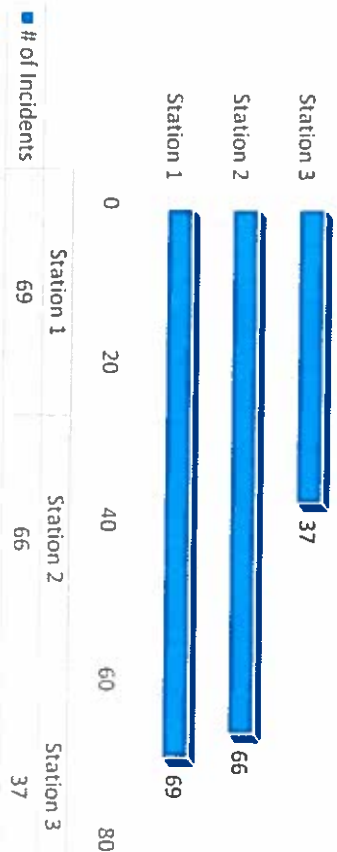
